

CREDIT DATA OPT-OUT FORM - Mortgage

Access to credit is an important part of your financial planning whether you are making an investment or dealing with an emergency situation. A good credit profile is an asset that is built up over time as your account activities are reported to credit reference agencies. Making sure you have that positive profile available provides greater certainty that you will be able to borrow when you have a need. Therefore, we suggest that you carefully think through a decision that you would permanently remove your records and this asset from the credit reference agencies database.
